Gardner Township

Beginning at 215th St and Clare Rd, north along Clare Rd to Gardner city limits, following the city limits of Gardner and Edgerton to 215th St; on the South by 215th St.

Gardner Township 04

The small area in Gardner Township in the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of S 35, T 14, R 22.

Gardner Township 05

That area in Gardner Township in S26 & S 27, T 14, R 22 north of BNSF Railroad.

Gardner Township 19

The area of Gardner Township bounded on the north by 143rd St; on the east by Olathe City limits; on the south by 151st St to Waverly Rd, south on Waverly Rd to 159th St, west on 159th St to the Gardner city limit, following the city limit to 151st St, continue north to 143rd St, the point of beginning.
