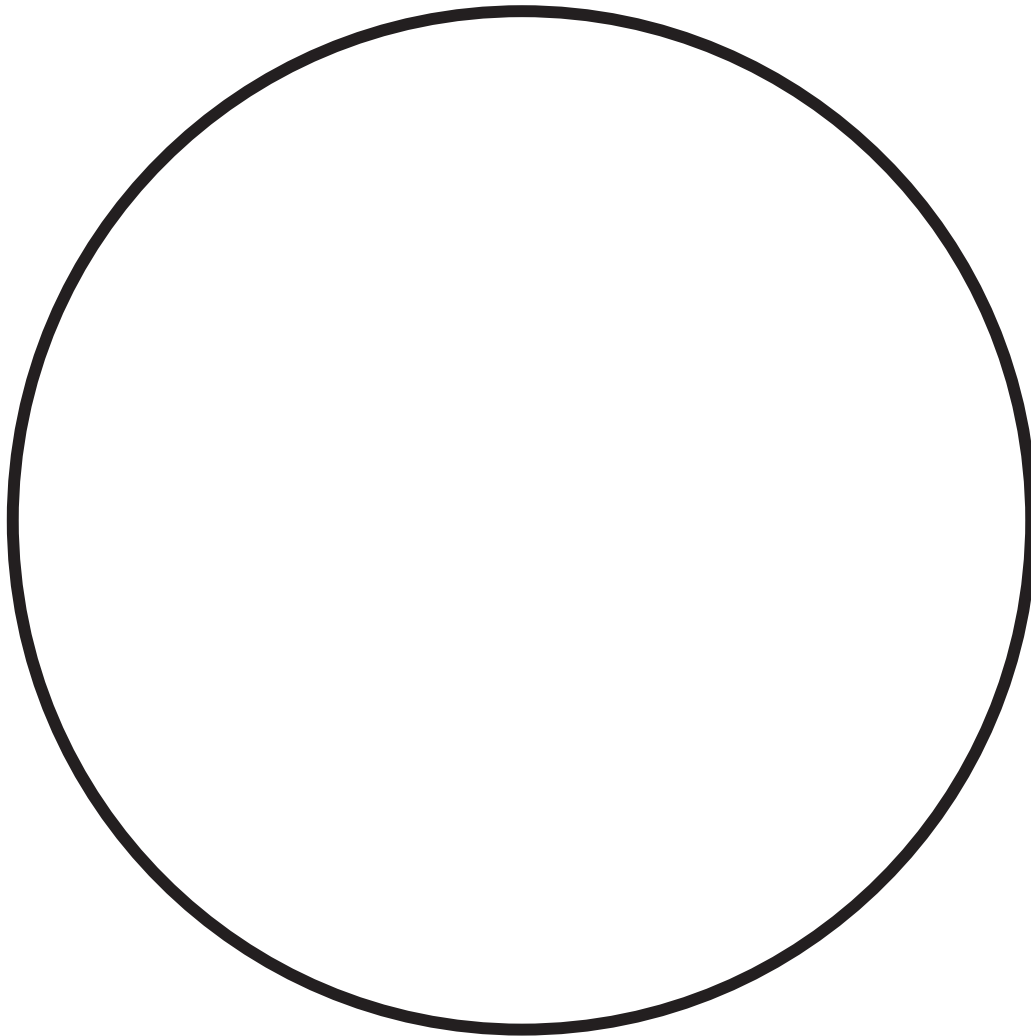

“I Voted” Sticker Design Contest: Rules

Overview

The Johnson County Election Office is excited to announce the “I Voted” Sticker Design Contest!

This contest celebrates democracy and the right to vote while promoting local creativity, connection, and pride in what makes Johnson County unique.

Residents of all ages are invited to submit original artwork that captures the spirit of voting in Johnson County. We aim to foster community identity and to encourage civic engagement for generations to come.

Your design can inspire thousands of voters and represent Johnson County’s values of public service, community and inclusivity in a way that is both meaningful and fun.

Four designs, one winning design per age group, will be chosen and distributed randomly at Advance Voting locations, in Advance Mail Ballot envelopes and on Election Day at all polling sites.

How to Enter

- Online

 - o Complete electronic form
 - Upload signed Release & Authorization Form OR *Parental* Release & Authorization Form
 - Upload high-resolution artwork OR scan hand-drawn artwork and upload
 - o **Submit by April 17 at 5 p.m.**
- In-person
 - o Download, print, complete and sign:
 - Entry Form
 - Release and Authorization Form
 - o Mail or drop off all forms and artwork to the Johnson County Election Office:

 - We recommend mailing **before April 10** to ensure timely arrival
 - o Submissions must be at the Election Office **by April 17 at 5 p.m.**

Categories (one winning design per age group)

- **Group 1: Ages 5-10**
- **Group 2: Ages 11-14**
- **Group 3: Ages 15-17**
 - o Must be a resident of Johnson County, Kansas, or must attend school, whether public, private or homeschooled, in Johnson County, Kansas.
 - o May not be a relative of an employee of the Johnson County Election Office.
 - o Entry must include the student’s first name, last name, and the name of their school.
 - o A signed Parental Release and Authorization form must be included with entry.
- **Group 4: Ages 18+**
 - o Must be a resident of Johnson County, Kansas.
 - o May not be a relative of an employee of the Johnson County Election Office.
 - o A signed Release and Authorization form must be included with entry.

Design Rules & Requirements

- All artwork...
 - o **Must** be participant's original work
 - o **Must** be submitted with the **entry design sheet**
 - o Should be clear and readable at a small scale
 - o Should be suitable for general audiences
 - o Will become and remain the property of the Johnson County Election Office
- Each individual may submit **one (1)** sticker design.
 - o Design **must** include: "I Voted" or "I Voted in Johnson County"
- Submissions may **NOT** include:
 - o Political party names, slogans or logos; Candidate names or campaign messaging
 - o Profanity or inappropriate material
 - o Copyrighted or trademarked material
 - o Material that infringes upon any person's right of privacy, publicity, or other right
 - o AI-generated artwork or use of AI tools to create or modify design
 - **The determination of the Johnson County Election Office shall be final.**

Submission Timeline

- Submissions are accepted from February 23 until **April 17 @ 5 p.m.**
- First round of review begins on April 20
- Second round of review begins on April 27
- Winners will be notified the week of May 25
- Winners will be publicly recognized on June 11

**“I Voted” Sticker Design Contest
Parental Release and Authorization**

By signing this Parental Release and Authorization:

1. I hereby agree that my minor child (“child”) may participate in the “I Voted” Sticker Design Contest hosted by the Johnson County Election Office (“Sponsor”). I irrevocably grant my permission and authorize the Sponsor to use my minor child’s name, school, artwork, and photograph in advertising, marketing, and promoting the contest, and to reproduce and publish the same in any media, without any additional notice to or permission by me or my child.
2. I waive any right to inspect or approve the completed media, finished product, copy, or other matter relating to this Contest.
3. I release the Sponsor from any claims, demands, damages, or liability, arising directly or indirectly, based upon distribution or use of material, or based upon any element of the contest. I hereby release the Sponsor, and its licensees and assigns, from any claims or liability in relation to, or arising from, my child’s participation in the contest.
4. I acknowledge that the Sponsor has no obligation to use my child’s artwork or information in the contest. I also acknowledge that use of my child’s work may be in conjunction with other children whose artwork has been selected.
5. I agree that the contest, my child’s participation, my child’s artwork and the contest elements belong entirely and exclusively to the Sponsor. I understand and agree that neither I nor my child will own any rights in any element of the contest or receive any monetary compensation relating to the contest.
6. I confirm that my child lives or attends school, whether public, private, or home-schooled, in Johnson County, Kansas. I consent to provide the information concerning my child that is necessary to enter the contest.
7. I agree that this consent and release will be governed by and construed in accordance with Kansas law.
8. I warrant that I am of legal age and have the right to contract in my name and on behalf of the child named below, and that I am the parent or legal guardian of the child named below, for whom this Release is granted. I have read and understand the **Rules of the “I Voted” Sticker Design Contest**, which is attached and part of the Release and Authorization, and the provisions of this Release and Authorization; I agree to the terms set forth in both and agree that my child and I are bound by the terms of both. This Release and Authorization shall be binding upon me, my child, our heirs, legal representatives, and assigns.
